SPECIFIC AGREEMENT FOR THE EXCHANGE OF STUDENTS AND ACADEMIC PERSONNEL, EXECUTED BY **UNIVERSIDAD DE GUADALAJARA, MÉXICO**, HEREIN REFERRED TO AS “**UDEG**”, REPRESENTED IN THIS ACT BY ITS RECTOR GENERAL, DR. RICARDO VILLANUEVA LOMELÍ, AND THE SECRETARY GENERAL, MSc. GUILLERMO ARTURO GÓMEZ MATA, AND BY **ZONGULDAK BÜLENT ECEVİT UNIVERSITY, TURKEY**, HEREIN REFERRED TO AS “**ZBEÜ**”, REPRESENTED BY THE RECTOR İSMAİL HAKKI ÖZÖLÇER, PH.D., ASSISTED BY THE VICE RECTOR HAKAN KUTOĞLU, PH.D.; PURSUANT TO THE FOLLOWING STATEMENTS AND CLAUSES:

STATEMENTS

“**ZBEÜ**” DECLARES:

- I. That it is a public body established by Supplementary Item 9 of the Law No. 3837 published 21281 of official Gazette of Republic of Turkey dated 11.07.1992. SUPPLEMENTARY ITEM 9. — A new university named Zonguldak Karaelmas University has been established in Zonguldak. The name of the University was changed by Item 18 of Law No. 6287 published in issue 28261 of official Gazette of Republic of Turkey dated 11.04.2012. ITEM 18 – The statement “Zonguldak Karaelmas University” in the title and sub-item one of supplementary item 9 of Law No. 2809, Law of Organisation of Higher Education Institutions dated 28 / 3 / 1983 has been changed as “Bülent Ecevit University”. The name of the University was changed by Item 6 of Law No. 7141 published in issue 30425 of official Gazette of Republic of Turkey dated 18.05.2018. ITEM 6 — The statement “Bülent Ecevit University” in the title and sub-item one of this item has been changed as “Zonguldak Bülent Ecevit University”.
- II. As stated in item 4 of the Regulation for Academic Organisation in Universities issued in issue 17609 of official Gazette of Republic of Turkey dated 18.02.1982, the Rector represents the legal entity of Universities. Prof. İsmail Hakkı Özölçer was appointed as the Rector of Zonguldak Bülent Ecevit University by Decree of Presidency dated 07.04.2022 numbered 2022/133.
- III. That its stated aims are to train individuals in associate, bachelor and graduate levels, professionals, graduates and other human resources that require the socio-economic development of Turkey; to organize, carry out, encourage and disseminate scientific technological and humanistic research, to provide high quality health, social, cultural and educational services, and to work alongside the competent educational authorities in the orientation as well as with the development of science and technology, all of this mentioned in related items of Turkish Law No 2547.
- IV. That designates as responsible for the execution of this agreement holder of the Vice Rector for International Affairs, or person to whom delegates functions.



V. That the legal address is the property located at Zonguldak Bülent Ecevit University Farabi Campus, 67100 İncivez, Zonguldak, Turkey.

"UDEG" DECLARES:

- I. That it is a public body, decentralized from the State Government of Jalisco; it is a legal entity with full autonomy and property ownership rights, conforming to that which is stated in article 1 of its Organic Law, promulgated by the local Executive on the 15th day of January, 1994, in execution of the decree number 15319 of the Honourable Congress of the State of Jalisco.
- II. That its stated aims are to train and update technicians, high school diploma holders, professional technicians, professionals, graduates and other human resources that require the socio-economic development of the State; to organize, carry out, encourage and disseminate scientific, technological and humanistic research, to uphold, conserve, increase and spread cultural awareness, and to work alongside the competent educational authorities in the orientation and promotion of upper-intermediate and higher education, as well as with the development of science and technology, all of this in keeping with article 5 of its Organic Law.
- III. That it conforms to article 6, section III of its Organic Law, in that it undertakes programs of teaching, research and the diffusion of cultural awareness, in agreement with the principles and directions laid out in article 3 of the Political Constitution of the Mexican United States.
- IV. That the Rector General is the highest executive authority and the legal representative of Universidad de Guadalajara, conforming to that which is stipulated in article 32 of the Organic Law.
- V. That the Secretary General, conforming to article 40 of the often-quoted Organic Law, is responsible for certifying the acts and provision in the terms of the law.
- VI. That designates as responsible for the execution of this Agreement the holder of the Coordination of Internationalization, or person to whom delegates functions.
- VII. That indicates as legal domicile, the property located in the Juárez Avenue number 976, C.P. 44100 in Guadalajara, Jalisco.
